- 4. Dr. Santosh Apte suggested following quality initiatives to be undertaken by the IQAC in consult with suggestions by IQAC members:
 - a. Review of Institute's Internal Complaint Committee (Women's Grievance Cell) policy: IQAC reviewed Internal Complaint Committee (Women's Grievance Cell) policy and procedures to ensure that policies and procedures are appropriate and provide an up-to-date framework in which decisions can be made and implemented. IQAC suggested few changes in its policy
 - b. Mapping of CO's, PSO's and PO's IQAC suggested to map CO's, PSO's and PO's to be done in the different mapping tables. IQAC suggested process of attainment of COs, POs and PSOs.
 - c. Updation in Course file Index: IQAC Coordinator after having studying the NAAC requirements suggested imparting quality in the Course file contents upgradation. A refined table of Contents for Course file was suggested.

d. Online book renewal: IQAC suggested having an online renewal of books through an email so as to make the book renewal procedure faster and efficient
