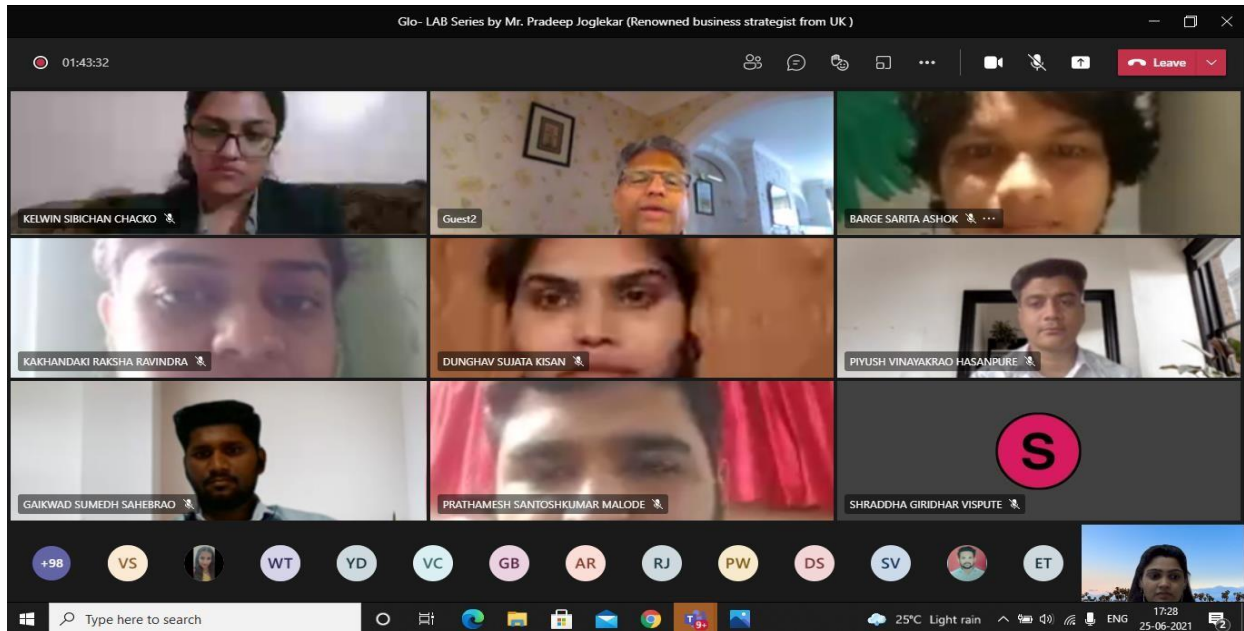

1. Objective:

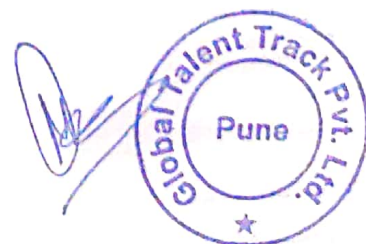
The objective of this MOU is to enable students of Zeal Education Society access resources that would enhance their employability.

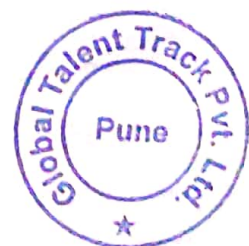

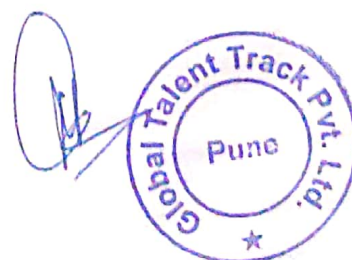

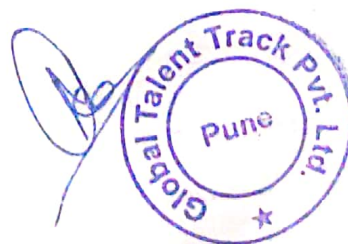


12. Confidential Information:

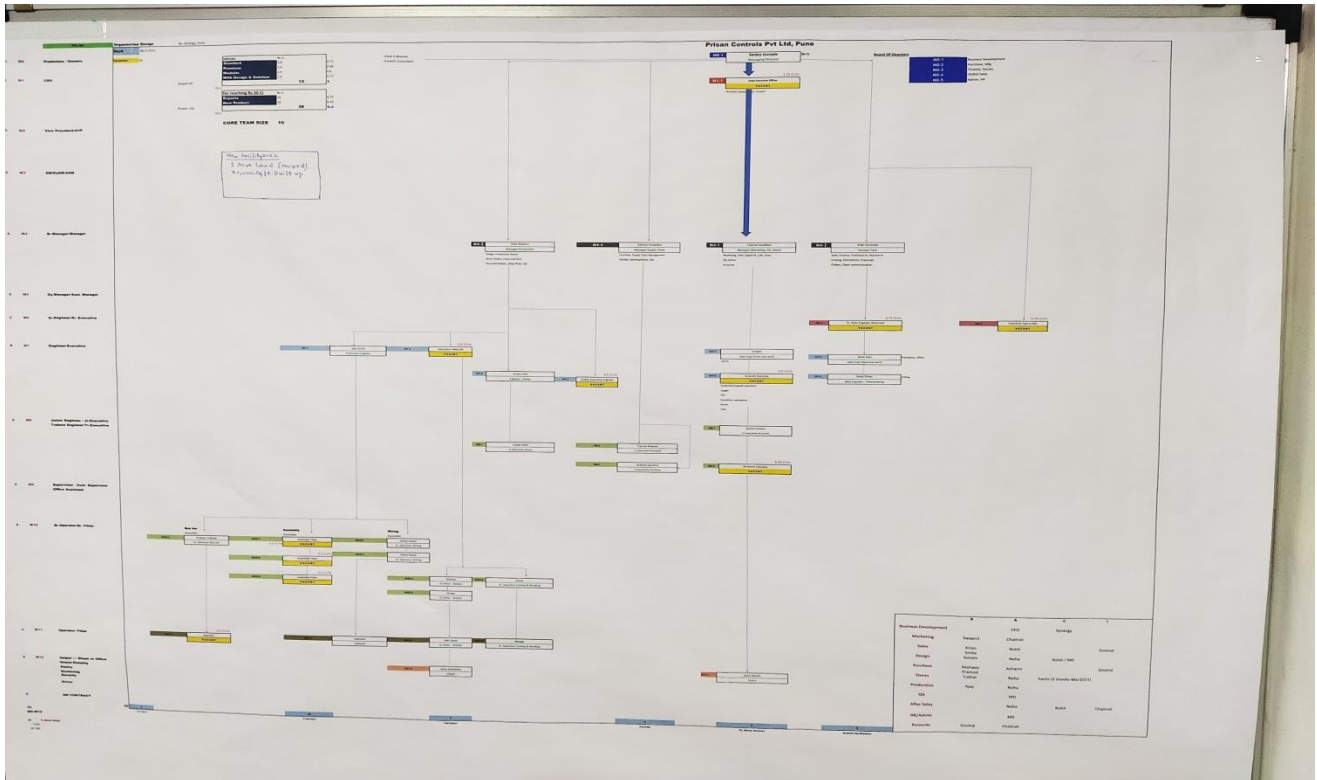
9. CONTRIBUTION OF THE MANAGEMENT
